Speaker Bios

Julie Brill

As Microsoft's global authority on the responsible use of data, Julie leads Microsoft's work at the forefront of the tech policy, regulatory, and legal issues that underpin the world's digital transformation. Julie oversees Microsoft's privacy, digital safety, responsible AI, standards, accessibility, and governance operations and solutions. She also directs the company's advocacy for responsible data use and policy around the globe. Prior to her role at Microsoft, Julie was nominated by President Obama and confirmed unanimously by the US Senate and served as a Commissioner of the US Federal Trade Commission (FTC). Julie is active in civil society, serving as a board member of the International Association of Privacy Professionals, a board member of the Center for Democracy and Technology, Governor for The Ditchley Foundation, and co-chair of Business at the Organization of Economic Cooperation and Development's Committee for Digital Economic Policy. She has received numerous accolades for her work, including the Privacy Leadership Award from the International Association of Privacy Professionals, a [Top Data Privacy Influencer recognition](#), the [New York University School of Law Alumna of the Year Award](#) and was elected to the American Law Institute. Brill graduated *magna cum laude* from Princeton University, and from New York University School of Law, where she held a Root-Tilden Scholarship for her commitment to public service.

Omer Tene

Omer Tene is a Partner at Goodwin Procter LLP Law based in the Boston office. He previously was a Vice President and Chief Knowledge Officer at the International Association of Privacy Professionals (IAPP) and now serves as an IAPP Senior Fellow. He is an Affiliate Scholar at the Stanford Center for Internet and Society and a Senior Fellow at the Future of Privacy Forum.

Stacey Schesser

Stacey Schesser is the Supervising Deputy Attorney General for the Privacy Unit in the Consumer Protection Section of the Office of the California Attorney General. Her recent matters include *People v. Glow*, *People v. Equifax*, and leading the team that drafted regulations for

the California Consumer Privacy Act (CCPA). She began her career at the Attorney General's Office in 2007 in its Criminal Division and has worked in the Privacy Unit since its inception in 2012. In 2019, Stacey was recognized as one of the Recorder's "Women Leader in Tech Law" and was the only public sector recipient of this award. Stacey received her J.D. at UC Berkeley's School of Law, where she wrote on privacy law issues for the California Law Review, and received her B.A. at Douglass College, Rutgers University.

Florian Schaub

Florian Schaub is an Assistant Professor in the School of Information. His research focuses on empowering users to effectively manage their privacy in complex socio-technological systems. His research interests span privacy, human-computer interaction, mobile and ubiquitous computing, and the Internet of Things. Before joining the University of Michigan, he was a postdoctoral fellow in the School of Computer Science at Carnegie Mellon University. He received his doctoral degree and Diplom in Computer Science from the University of Ulm, Germany, and a Bachelor in Information Technology from Deakin University, Australia.

Ari Ezra Waldman

Ari Ezra Waldman is a professor of law and computer science and the faculty director of the Center for Law, Information, and Creativity at Northeastern University. He is a widely published scholar, with articles published or forthcoming in the California Law Review, the Michigan Law Review, the Washington University Law Review, the Cornell Law Review, and the Iowa Law Review, among many others. His book, *Industry Unbound*, pulls back the curtain and goes inside the information industry to reveal how tech companies undermine privacy law. He was named one of the Top 20 Thinkers of 2020 by Prospect Magazine, was elected to the ALL in 2019, and received the Best Paper Award at the Privacy Law Scholars Conference twice. He serves on the editorial board of the peer-reviewed journal, *Law & Social Inquiry*, and is the Chair of the Privacy Law Scholars Conference. He earned a PhD in sociology from Columbia University, a JD from Harvard Law School, and an AB, magna cum laude from Harvard College.
