**APPLICATION FOR FORDHAM LAW SCHOOL'S CLERKSHIP LOAN REPAYMENT
ASSISTANCE PROGRAM**

Graduates who accept a two-year judicial clerkship or two consecutive one-year clerkships may apply to this Loan Repayment Assistance Program (LRAP). The repayment assistance will be in the form of a loan to assist in the repayment of Law School Federal and private loans for the two-year period. No interest will accrue on these loans during the clerkship period, plus six months thereafter. Interest will begin to accrue on the total loan award at the rate of 4% per annum at the end of the six-month grace period. Repayment will commence one month later. The repayment term will depend upon the amount borrowed and will be based on the current Revolving Loan Repayment Schedule, but the term will not exceed 15 years. Graduates who have borrowed through the Law School's Revolving Loan Fund are entitled through the Loan Forgiveness Program to a no-interest deferment on these loans during the clerkship period. If you borrowed from the Revolving Loan Fund, you need only complete this application to obtain the deferment on those loans.

- (3) Copies of billing statements for all education loans for which you are seeking loan repayment assistance. Billing statements must indicate the amount of each installment and whether the payments are made monthly or quarterly.

Applicants are advised to apply no later than one month prior to the date the clerkship will begin and will be required to be recertified every six months during the two-year period. One-half of the loan for the first year of the clerkship will be disbursed upon acceptance into the program. The second, third and fourth loan disbursements will be made at six-month intervals upon being recertified.
