Please call Fordham's Office of Development (212-636-6550) if you have questions about transferring mutual fund shares, physical securities, or Treasury securities to Fordham. Once you have decided on the stock/s you will transfer to Fordham, please provide the instructions below to your broker for the electronic transfer of stock. Kindly allow sufficient processing time by your broker, particularly at calendar year-end, when at least two weeks may be required.

Please instruct your broker to include your name as the donor on all gift deliveries. We encourage you or your broker to contact our office with notice of the gift being conveyed, to help ensure that Fordham can expeditiously record and acknowledge your gift for tax purposes and allocate the proceeds in accordance with your wishes.
