MAJOR FELLOWSHIPS

Institute of International Education U.S. Department of State Fulbright U.S. Student Program

The Institute of International Education (IIE) accepts and screens applications for the U.S. Department of State Fulbright U.S. Student Program, which provides grants for study, research, and professional training abroad. Each year, the program allows Americans to study or conduct research in approximately 140 nations. Applicants must be U.S. citizens and, in most cases, must hold a bachelor's degree. Professional experience or training, especially in the arts, may substitute for degrees in some cases. Language requirements vary. In general, grantees should be able to communicate with people in the countries in which they study. See Geri Rypkema in the GW Fellowships and Grants Office.

Social Science Research Council International Dissertation Research Fellowship

The International Dissertation Research Fellowship (IDRF) Program supports distinguished graduate students in the humanities and social sciences, enrolled in doctoral programs in the United States, conducting dissertation research outside the United States. Seventy-five fellowships ranging from \$10,000 - \$20,000 will be awarded with funds provided by the Andrew W. Mellon Foundation.

The IDRF program is committed to scholarship that advances knowledge about non-U.S. cultures and societies grounded in empirical and site-specific research (involving fieldwork, research in archival or manuscript collections, or quantitative data collection). The program promotes research that is situated in a specific discipline and geographical region and is engaged with interdisciplinary and cross-regional perspectives. Applicants must have completed all Ph.D. requirements except on-site dissertation research by the time the fellowship begins. Fellowships will provide support for nine to twelve months of dissertation research. The fellowship must be held for a single continuous period within the eighteen months.

Charlotte W. Newcombe Doctoral Dissertation Fellowships

Charlotte W. Newcombe Doctoral Dissertation Fellowships are designed to encourage original and significant study of ethical or religious values in all fields of the humanities and social sciences. Proposals should have ethical or religious values as a central concern. Dissertations may consider any historical period, but should be concerned with continuing human problems and have contemporary relevance. For instance, previous awardees have addressed issues such as religious tolerance, human rights, spiritual beliefs in comparative perspective, justice, racial and gender equity issues as these are expressed through ethical or religious concerns.

Since the first round of competition in 1981, more than 1,000 Newcombe Fellows have been named. Fellows from early years of the program are now senior faculty at major research universities and selective liberal arts colleges, curators and directors at significant scholarly archives, and leaders and policymakers at nonprofit organizations and in cabinet-level government agencies. In the past decade, Newcombe Fellows have received national honors such as the MacArthur Fellowship, the Guggenheim Fellowship, and election to the American Academy of Arts and Sciences.

The 2012 Newcombe Fellows will receive \$25,000 for 12 months of full-time dissertation writing. (No half-year or partial awards are allowed.) At least 21 non-renewable fellowships will be awarded to candidates selected from among more than 500 applicants. Graduate schools will be asked to waive tuition for Newcombe Fellows.

ELIGIBILITY

Applicants for the Charlotte W. Newcombe Doctoral Dissertation Fellowships must be doctoral candidates at the writing stage of their dissertation for Ph.D. or Th.D. degrees in any field of study at graduate schools in the United States. Candidates must have completed all predissertation requirements, including approval of the dissertation proposal, by November 15, 2011. Fieldwork or other research must be complete and writing begun by the time of the award. Candidates should expect to complete their dissertation between April and August 2013.

Applicants with D.Min., law, Psy.D. and other professional degrees are not eligible. Applicants who have held a similar national award for dissertation writing, such as an ACLS, Ford, Pew, Spencer, MacArthur, Whiting, Mellon, or AAUW fellowship, are not eligible. Mellon Fellowships for Dissertation Research in Original Sources

The Council on Library and Information Resources offers research fellowships funded by The Andrew W. Mellon Foundation for graduate students in the humanities or related social sciences. Students must be enrolled in a doctoral program in a U.S. graduate school and plan to do dissertation research primarily in original source material in the holdings of archives, libraries, historical societies, museums, related repositories, or a combination. Research may be conducted in the U.S., internationally, or both. Stipends up to \$25,000 for periods of 9 to 12 months.

Mellon/ACLS Dissertation Completion Fellowships

- Stipend: \$25,000, plus funds for research costs of up to \$3,000 and for university fees of up to \$5,000
- Tenure: one year beginning summer 2012

- Completed applications must be submitted through the ACLS Online Fellowship Application system (ofa.acls.org) no later than 9 p.m. Eastern Standard Time, November 9, 2011.
- Notifications will be sent in late March 2012.

ACLS invites applications for the sixth annual competition for the **Mellon/ACLS Dissertation Completion Fellowships**, which support a year of research and writing to help advanced graduate students in the humanities and related social sciences in the last year of Ph.D. dissertation writing. The program encourages timely completion of the Ph.D. Applicants must be prepared to complete their dissertations within the period of their fellowship tenure and no later than August 31, 2013. A grant from The Andrew W. Mellon Foundation supports this program.

ACLS will award 65 Fellowships in this competition for a one-year term beginning between June and September 2012 for the 2012-2013 academic year. The Fellowship tenure may be carried out in residence at the Fellow's home institution, abroad, or at another appropriate site for the research. These Fellowships may not be held concurrently with any other fellowship or grant.

The total award of up to \$33,000 includes a stipend plus additional funds for university fees and research support. In addition to the monetary support that the fellowship offers, Dissertation Completion Fellows are able to apply to participate in a seminar on preparing for the academic job market. The seminar takes place over three days in the fall of the fellowship year.

- **Research Fellowships** for use in Eastern Europe to conduct fieldwork or archival investigations.
- **Writing Fellowships** for use in the United States, after all research is complete, to write the dissertation.

Applications should be for work on Eastern Europe: Albania, Bosnia and Herzegovina, Bulgaria, Croatia, Czech Republic, Estonia, Hungary, Kosovo/a, Latvia, Lithuania, Macedonia, Montenegro, Poland, Romania, Serbia, Slovakia, and Slovenia.

Bourse Chateaubriand (French Embassy)

The Chateaubriand Fellowship is a grant offered by the Education Office of the Embassy of France in the United States. Every year, the Chateaubriand Fellowship allows Ph.D. students enrolled in American universities to conduct research in France for up to 9 months. The stay in France can range in length, from 6 to 9 months, depending on the needs of the student. Each candidate must explain how many months he or she would like to spend in France and why. Chateaubriand Fellows receive a stipend of €1400 per month, one round-trip ticket to France, and health insurance coverage for the period of the grant.

Boren Fellowships for International Studies

Boren Fellowships provide up to \$30,000 to U.S. graduate students to add an important international and language component to their graduate education through specialization in area study, language study, or increased language proficiency. Boren Fellowships support study and research in areas of the world that are critical to U.S. interests, including Africa, Asia, Central & Eastern Europe, Eurasia, Latin American, and the Middle East. The countries of Western Europe, Canada, Australia, and New Zealand are excluded. Boren Fellows represent a variety of academic and professional disciplines, but all are interested in studying less commonly taught languages, including but not limited to Arabic, Chinese, Korean, Portuguese, Russian and Swahili.

Paul and Daisy Soros Fellowships

Below please find information on The Paul and Daisy Soros Fellowships, which award up to \$90,000 over two years: \$25,000 a year for maintenance and up to \$20,000 year for tuition. The fellowships are specifically for New Americans (naturalized citizens, resident aliens or a child of two parents who are both naturalized citizens).

Purpose

The Paul & Daisy Soros Fellowships (<http://www.pdsoros.org/>) for New Americans provide opportunities for continuing generations of able and accomplished new Americans to achieve leadership in their chosen fields. The program is established in recognition of the contributions New Americans have made to American life and in gratitude for the opportunities the U.S. has afforded the donors and their family.

Award

Thirty Fellowships will be awarded each year for any academic discipline or professional field. Each year the Fellow receives a maintenance grant of \$20,000 (paid in two installments) and half-tuition (up to \$15,000 per academic year).

Eligibility Requirements for Students

- A New American is an individual who (1) is a resident alien; i.e., holds a Green Card or, (2) has been

naturalized as a U.S. citizen or, (3) is the child of two parents who are both naturalized citizens. A Green Card holder must have had more than one year of IRS filings.

- The program is open to individuals who retain loyalty and a sense of commitment to their country of origin as well as to the U.S., but is intended to support individuals who will continue to regard the U.S. as their principal residence and focus of national identity.
- The applicant must either have a bachelor's degree or be in her/his final year of undergraduate study. Those who have a bachelor's degree may already be pursuing graduate study and may receive Fellowship support to continue that study. Individuals who are in the third, or subsequent, year of study in the same graduate program are not, however, eligible for this competition. Students who have received a master's degree in a program and are continuing for a doctoral degree in the same program are considered to have been in the same program from the time they began their work on their master's degree.
- No more than two years in a graduate program at the time of application.
- Applicant must not be 30 years of age or older at the time of application.

Selection Procedures

Candidates must demonstrate the relevance of graduate education to their long-term career goals and potential in enhancing their contributions to society. A successful candidate gives evidence of at least two of the following three attributes or criteria for selection:

- Creativity, Originality, and Initiative, demonstrated in any area of her/his life

Louisville Institute Dissertation Fellowships

The Louisville Institute's Dissertation Fellowships support the final year of Ph.D. or Th.D. dissertation writing for students engaged in research pertaining to American religion. Preference will be given to those proposals that address the current program priorities of the Louisville Institute especially those having to do with Christian faith and life, pastoral leadership, and religious institutions. Up to seven fellowships of \$19,000 each will be awarded.

German Academic Exchange Service

Research Grant

Research grants are awarded primarily to highly qualified PhD candidates who are early in their academic/professional careers and wish to undertake research in Germany. Funding may also be granted to recent PhDs who would like to conduct postdoc research or individuals wishing to work towards a German doctorate.

Requirements: Applicants in all academic fields are welcome to apply. For research in medicine or dentistry, please contact DAAD for special guidelines. Applicants are expected to have a well-defined study or research project that makes a stay in Germany essential and should have been invited by an academic partner at a German university or research institution to pursue their project. Applicants in the arts, humanities, and social sciences should have a very good command of German.

Terms of Award: Graduate Research Grants are awarded for one to ten months. Applicants wishing to complete a doctoral degree program in Germany may receive up to three one-year extensions.

Monthly stipend is approximately €1,000. In addition, DAAD will cover health insurance and travel costs.

American Society for Eighteenth-Century Studies Irish-American Research Travel Fellowship

The American Society for 18th-Century Studies (ASECS) offers the Irish-American Research Travel Fellowship (\$1500) to support documentary research on Ireland, in any discipline, in the period between the Treaty of Limerick (1691) and the Act of Union (1800). Awarded yearly, the fellowship is open to ASECS members who are resident in North America, and all members of ASECS' Irish sister organization, the Eighteenth-Century Ireland Society, who are resident in the Republic of Ireland or Northern Ireland. It is restricted to documentary scholars, whose research centers on primary sources from the 18th century (manuscripts, printed matter, buildings, works of art, or other artifacts) rather than on the secondary literature already extant.

The Library offers reference advice to prospective researchers and grant applicants, and provides search reports from its PRESNET database of more than 100,000 folders representing more than 90% of the historical material available to research.
